In these minds there are extremely serious threats to the physical health of the population [2]:

3. As a result of the conflict, many people can waste their time, worrying about their time-consuming minds, which can lead to a deterioration in their physical health.

4. This situation leads to a shortage of medical assistance and limited access to medical supplies, which complicates the treatment of the wounded.

Psychological health:

1. Insecurity and fear in the minds of possible attacks can cause permanent stress and affect the mental health of the population.

2. The loss of family members or friends through military operations can cause deep trauma and emotional distress.

3. Moving, loss of work, and the instability of the minds of life lead to a psychological pressure on the population, especially on children and older people.

4. Increased violence, trauma and loss can lead to post-traumatic stress syndrome and other mental disorders.

The detailing of these threats serves as the foundation for further understanding and development of defense strategies aimed at minimizing the influx of military conflict on the physical and mental health of the civilian population along the line.

The protection of the civilian population has its own peculiarities, where enemy sides are hidden. The risks for the citizens move through the direct influx of military operations. What is needed here are not only advanced security approaches, but also strategies, specially adapted to the specific minds of the military conflict. Problems with access to medical care, the collapse of infrastructure, and increased fear and anxiety among the civilian population will all require a comprehensive and complex look. Effective protection near the confinement line requires an integrated approach that promotes security, evacuation, and psychological support for the population.

Analyzing the current state of nutrition and the peculiarities of protection, we are preparing ground for further development and development of strategies aimed at changing the risks and maximizing security for communities, especially those who are closest to the conflict zone.

For this purpose, it is necessary to carry out [3]:

1. The use of statistical data and conflict zone reports to determine the main trends in the impact of military operations on the civilian population.
2. Conducting tailored interviews and surveys among citizens to gather information about their own experiences and perceptions of threats.
3. Involvement of experts in psychology, medicine and military strategy to develop complex methods of protection.
4. Systematic monitoring and analysis of the effectiveness of security measures, including warning and evacuation systems.

That is why it is so important in the conditions of war to conduct an analysis of medical records regarding injuries and the state of health of citizens who were affected by the military conflict. Use reports from organizations such as the International Red Cross and Red Crescent to assess the humanitarian situation and the needs of civilians. Study media materials to determine the degree of influence of information about military events on the mental state of the population. To conduct analysis and monitoring of citizens' thoughts and impressions, which are covered in social networks, in order to collect information about their psychological situation.

All this work will make it possible to identify the main physical and psychological problems faced by the civilian population near the contact line. Based on the received data, develop an alert and evacuation system to ensure maximum safety of citizens in case of danger from an enemy attack. Implement psychological support and rehabilitation programs for those who have experienced trauma or lost loved ones in the controlled territories. Improve existing and implement new security measures to minimize physical threats to citizens.

This will allow the development of specific and effective strategies for the protection of the civilian population in conditions of full-scale war near the contact line in specific conditions.

Conclusions. Analyzing the state of the issue of protecting the civilian population in conditions of full-scale military conflicts, especially near the contact line, it becomes obvious that this task requires a complex approach and innovative solutions. The main conclusions can be formulated as follows:

1. The use of modern technologies and strategies is crucial in protecting citizens from direct military actions, artillery fire and other physical threats.

2. Psychological support of the civilian population is key, that is why it is so important to make it available to all sections of the population to reduce psychological pressure and improve the mental condition of citizens.

3. Widely implement effective systems of notification and evacuation of the population to ensure a quick and safe response to threats.

4. To implement comprehensive measures to preserve physical and psychological health, which will allow to provide full protection for the civilian population.

In general, consideration and analysis of the issues of protection of the civilian population in the conditions of full-scale military conflicts made it possible to formulate the principal directions of further actions to ensure the safety and well-being of citizens in the conditions of a military conflict. The combination of effective methods and innovative solutions is a key element in creating sustainable and effective protection of the civilian population.
